Clinic Observations...

Students will be permitted to observe the therapy sessions from the week of September 15th through the week of November 17th. Student observers should comply with the clinic's rules and regulations, or you will be asked to leave, and may not be allowed to observe in the future. The sign-up sheet to observe will be posted on the bulletin board inside the clinic prep room.

HEADSTART SCREENINGS...

Completion of speech and hearing screenings at the local headstart facilities will be available for seniors and graduate students to get extra clinical hours. Dates and times will be posted in the clinic preparation room. You will need to sign up for the times that you will be available to go. If you do not sign up, times will be assigned to you. Please note.... You will need to provide your own transportation to the facilities that are listed on the postings, unless a waiver is signed to go with one of the supervisors.

Rules for Observation in the Marywood Speech and Hearing Clinic:

1. Sign up to observe (sign up sheet is on the bulletin board in the clinic prep room). Be prepared and allot 45- 1 hour (if you have classes that are close to the observation time, you should be aware of the time constraints.) You will need to fill out appropriate paperwork in its' entirety before leaving the clinic area.
2. Arrive 5-10 minutes early, so that you can speak with the clinician prior to the start of the session, ask any questions that you should have and fill out initial sections of the observation form.
3. Dress appropriately, as you will be interacting with clinicians and families. (If you are unsure of what is appropriate, please see one of the clinical supervisors.)
4. Get the appropriate forms (observation sheet)
5. Be quiet in the clinic area.
6. Keep all belongings with you, not on the floor in the clinic area.
7. Ask the supervisor/clinician to get you a headset and chair.
8. Fill out the observation sheet while you watch the therapy session.
9. Get the signature from both the supervisor and the student clinician when the therapy session is completed. (please be advised that you should not interrupt a clinician and/or supervisor to sign your sheet if they are speaking

with the client and/or family member.)

10. If you need to cancel your observation time, you need to do so with the supervisor at least one hour prior to the therapy session.
11. *Always respect client confidentiality in and out of the clinic*
